It is the goal of the Chauncey B. Warner Home for Little Wanderers Campership Committee to provide financial support for low income children in Franklin County so that they may attend an enriching summer experience. The Campership Grant can support various forms of summer camps or programs related to academics, sports, arts, music, recreation, medical, and others.

Requests for funding for year-round activities swim lessons should be directed to the Warner Home Endowment Committee using their application on our website. Children may receive funding from both sources in the same year.

Eligibility Guidelines:

- Child must be a resident of Franklin County, Vermont and under 21 years old.
- Income eligibility guidelines are based on Vermont's Free and Reduced Lunch income levels (which are currently 185% of the Federal Poverty income limits) plus \$5,000 of income. Please note that proof of income may be required. Please report the total amount of gross annual income from all sources (earned, child support, other supports).

Please:

- Use a separate form for each child
- Indicate if applying for assistance for multiple camps
- Indicate if a child is in DCF custody or has a documented disability

What to expect:

- If your child is ineligible or funds are not available, you will receive a letter stating the reason for their denial.
- If your child is eligible and funding remains, you will receive an award letter indicating the amount of their grant. You must give or send the letter to the camp administrator who will bill the Warner Home Corporation directly. You will be responsible for paying any balance between the cost of the camp and the amount of the award. Awards are transferable to a different camp if your plans change.

Awards will be granted beginning March 1 and will continue to be granted until funds are no longer available.
